Answers to Your Most Common Questions

1. What is 10-Year Group Term Life Insurance? How does it work?

Term Life coverage is the purest kind of life insurance, meaning there are no costly savings features. This 10-Year Group Term Life Insurance is life insurance coverage that can be purchased at a level rate for ten years.
